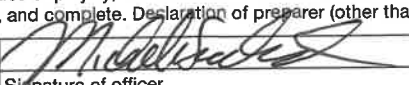

(a) Assistance Dog Training. Founded in 1979, Paws With A Cause custom matches, trains and places four types of Assistance Dogs: Service Dogs, for adults with mobility issues; Seizure Response Dogs, for adults with epilepsy; Hearing Response Dogs, for adults who are deaf or hard of hearing; and Service Dogs for Children with Autism, for families with a child under the age of 12 with Autism. Dogs are individually matched to each client using a unique breeding, puppy training and evaluation process. Training is personalized for each client, relying on an experienced staff of professional dog trainers and handlers to teach and master skills specifically selected to mitigate each individual client's disability. PAWS provides ongoing support including continued training and public access advocacy to each team for the lifetime of the team.

(b) Facility Dog Training. PAWS trains and places Facility Dogs with institutional clients including but not limited to: K-12 schools, colleges and universities and hospitals. PAWS uses its unique proprietary model to custom match and train each Facility Dog to meet the needs of each institutional client. PAWS provides continued training, education and support to each team for the lifetime of the team.

(c) Volunteer and Community Outreach. The Paws With A Cause volunteer program provides an opportunity for volunteers to impact the lives of individuals with disabilities and our communities through a spectrum of volunteer options from breeding and whelping of puppies through integral on-campus volunteer experiences. Volunteers assist with raising and providing puppy training for the first 14 months of a puppy's life, supporting dog enrichment programs for dogs in training on PAWS campus, community presentations, administrative support and many other daily activities to ensure the health, welfare and success of each PAWS Client/Dog Team.
